**Notice by Affidavit**

**Notice of Affidavit to South Carolina State Legislature as a Demand for Action**

**Notice of Affidavit to Agent is Notice of Affidavit to Principal and Notice of Affidavit to Principal is Notice of Affidavit to Agent**

Now comes Affiant, \_\_\_\_\_, one of the People (as seen in Article 1 Section 1 of the South Carolina Constitution) Sui Juris, in this court of Record, am serving you with due notice, that you may provide due care and heed this demand for a secure, free, and fair election. Securing the right to truly elector representatives is of the highest priority.

Please take notice that all government officials are simply the servants and the trustees of the people. Government is and has always been based on the will of the People. No public officer is to handle the peoples' business based on his or her own will.

I, as one of the people would like to remind you of the oath you took when sworn into office per the South Carolina State Constitution Article 3, Section 26:

"I do solemnly swear (or affirm) that I am duly qualified, according to the Constitution of this State, to exercise the duties of the office to which I have been elected, (or appointed), and that I will, to the best of my ability, discharge the duties thereof, and preserve, protect and defend the Constitution of this State and of the United States. So help me God."

Please take notice that you as a public servant are granted certain powers by the people and this granted authority is for the benefit of the people and that only their will be carried out.

The South Carolina Constitution, which you have sworn an oath to uphold, states **in Article 1, Section 1:**

**"All political power is vested in and derived from the people only, therefore, they have the right to modify their form of government.**

The faith of the people of South Carolina stands pledged to the preservation of a Constitutional Republic form of government and subject to this limitation only. We the people have at all times the inalienable right to alter, reform or abolish their government in such manner as they may think expedient. Not only the right but the duty as given to the people by the Declaration of Independence."

Furthermore, **Article 1 Section 2 affirms:**

**the "right of the people peaceably to assemble and to petition the government or any department thereof for a redress of grievances.**

I, as one of the people, am in full support of a full forensic audit of every county in the state. Our vote is our voice and the essential expression of our freedom. We must be able to verify that the 1824, Missouri Doctrine, "Once free, always free" remains true. It is a right of the people, as laid out in Section 2 of the Fourteenth Amendment that each individual member of the people has the express, inalienable right to a single, whole vote. The possibility that our vote has been reduced to something akin to the Three-fifths Compromise must be addressed.

Accordingly, I as one of the people, give notice that you must immediately do all things necessary to bring about the desired public, live-streamed, full and complete forensic audit, available to poll watchers, candidates or candidate representatives of any party to witness, analyzing:

---

All paper ballots (from the 2020 General Election and the pre-election system test ballots):

- Kinematic forensic analysis (utilizing high speed, high definition, digital forensic police cameras, and optical character recognition) of paper ballots
- Digital forensic analysis of ballot images both computer and human created, and any and all image codes,
- Forensic analysis of the paper and the print system utilized
- All possible ballots:
  - How many versions of ballots were there?
  - How many of each version could be counted?
  - How many of each version were counted?
  - How did the digital images of each effect the operation of the election equipment?
  - Was there any forensic variation within each ballot version?
  - Did the handling of ballots alter the effect of the ballot's interaction with any election equipment?

The tabulator tapes:

- Kinematic forensic analysis of the tabulator tapes
- A forensic analysis of their correlation to the equipment used, the software and the paper ballots
- The machines all equipment and software utilized before during and after the 2020 General Election:
- IACIS CFCE certified computer forensic analysts to find, extract, analyze and document all electronically stored information found on the counting/tabulator machines, pollbook machines, disability abled machines, routers, thumb drives, SOS laptops, and any other equipment not listed
- Forensic and kinematic analysis of all equipment used
- The networks:
- Full forensic network, and packet analysis of all connectivity

The people have the right to have a full forensic audit of the 2020 election. The task of ensuring free and fair elections falls on the South Carolina Legislature, as stated in the South Carolina Constitution in Article 2, Section 1 and 2:

**Section 1-**

**"All elections by the people shall be by secret ballot, but the ballots shall not be counted in**

secret. The right of suffrage, as regulated in this Constitution, shall be protected by laws regulating elections and prohibiting, under adequate penalties, **all undue influence from power, bribery, tumult, or improper conduct.**”

**Section 2-**

“No power, civil or military, shall at any time interfere to prevent the free exercise of the right of suffrage in this State.”

*Suffrage: A vote; the act of voting; the right or privilege of casting a vote at public elections. The last is the meaning of the term in such phrases as "the extension of the suffrage," "universal suffrage," etc. Right of "suffrage" is right of a man to vote for whom he pleases*

This audit should include every voting district of every county, throughout the state of South Carolina. Those contracted to perform the audit should be chosen by the will of the people. Full subpoena power shall be conducted by the state legislators to obtain the requirements for a full forensic audit.

I look forward to your speedy attention to these issues and look forward to the immediate corrective action that follows the powers and duties you were given in your Trust Indenture, the South Carolina Constitution.

Any man or woman who denies these claims are true must rebut them under penalty of perjury in the form of a sworn affidavit. Any man or woman who decides to suppress this affidavit agrees to pay \$1,000 and any disputes by any public officials or private actors who are bound by contract to the South Carolina State Constitution agrees to have these matters heard before an Arbitrator of my choice and to be bound thereby. Any man or woman denying these claims are true must rebut these claims point by point showing where you have the Continual Authority to ignore these rights of the people within (3) days (72hrs). Failure to respond means that by acquiescence you agree that all claims are true and you are acting in Maladministration.
